1. Boat Owner or agent must complete a Haulout Agreement and provide proof of insurance prior to haulout.
2. Haulout/pressure wash fees will be paid upon haulout and all yard fees will be paid monthly and all accounts paid in full **prior** to launch, cash, check, Visa, MasterCard, Discover, or American Express.
3. Emergency Haulouts / After-hours haulouts are subject to availability and will be charged an additional fee.
4. A disposal fee of \$1 per gallon will be charged for bilge water, fuel, and oil disposed of by the Shipyard.

STANDS ARE NOT TO BE MOVED BY CUSTOMERS! PLEASE CONTACT THE OFFICE TO SCHEDULE YOUR STAND MOVE. CUSTOMERS WHO MOVE THEIR OWN STANDS WILL BE IN VIOLATION OF THE HAULOUT CONTRACT AND BE SUBJECT TO A \$200.00 FINE.

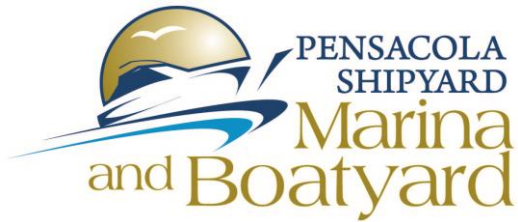

Pods, conex box, temp storage shed (ONLY WITH management approval)	\$30 Per week, additional charges will apply if power is utilized

Wet slips are available to the public on a “first come, first served” basis. Vessels moored at Pensacola Shipyard must complete a dockage agreement and provide proof of insurance immediately upon arrival.

SEAWALL & TRANSIENT DOCKAGE RATES:

Daily (1 TO 3 Days)	\$1.50 Per Foot Per DAY
Weekly (4 TO 7 Days)	\$7.50 Per Foot Per WEEK
Monthly (22 to 31 Days)	\$22.00 Per Foot Per MONTH

SLIP DOCKAGE RATES – MONTHLY:

A REFUNDABLE DEPOSIT (EQUIVALENT TO THE 1ST MONTHS FEES) ALONG WITH PROOF OF PROTECTION AND INDEMNITY INSURANCE, HULL INSURANCE COVERING THE VESSEL FOR ITS INSURABLE VALUE, AND DOCUMENTATION SHOWING PENSACOLA SHIPYARD LISTED AS ADDITIONAL INSURED IS REQUIRED FOR MONTHLY SLIP DOCKAGE AND LONG-TERM SEAWALL DOCKAGE. THE LICENSE AGREEMENT FOR SLIP FEES AND SEAWALL DOCKAGE IS MONTH TO MONTH WITH 30 DAYS WRITTEN NOTICE TO VACATE. A VESSEL OCCUPYING TWO SLIPS WILL BE BILLED FOR TWO SLIPS.

A and B Dock (includes water/slip side dockbox, power is metered)	\$11.50 Per Foot Per Month + tax
C Dock (includes water/slip side dockbox and power)	\$10.75 Per Foot Per Month + tax
